Dear Director Logan,

Enclosed are copies of absentee ballots showing that a person identified as both Trudy Garman and Trudy Wiseblood voted twice in the 2004 General Election and twice in the 2005 Primary Election. The following is a summary of registration information and the dates that the votes were cast:

There are several reasons to believe that Trudy Garman and Trudy Wiseblood are the same person:

1. Both identities registered at 16541 NE Redmond Way in Redmond. This is the address of Building A in Cleveland Street Square, a shopping center. According to the property manager, this property has no residential units. Neither identity specified a suite number which would be necessary to locate a specific business. The most probable is a private mail box rental company, Pony Express;
2. Both share the same birthday although different birth years;
3. The handwriting and printing of the two identities are almost identical; and
4. Both identities moved to Santa Rosa, California. Trudy Garman gave a residential address and telephone number on her 2005 ballot envelope. The address and telephone number given by Trudy Wiseblood is commercial property housing an organization identified as the Harvard Research Corporation. This organization is not registered with the State of California.

It is conceivable, but extremely unlikely, that these are two different people with a close association who share the same handwriting and birthday. However, I called Trudy Garman and she denied knowledge of how to contact Trudy Wiseblood. As a private citizen with limited resources and authority I am unable to conduct further investigation.

RCW 29A.84.650 provides:

- (1) Any person who intentionally votes or attempts to vote in this state more than once at any election, or who intentionally votes or attempts to vote in both this state and another state at any election, is guilty of a class C felony.
- (2) Any person who recklessly or negligently violates this section commits a class 1 civil infraction as provided in RCW 7.80.120.

Ms. Garman/Wiseblood declared that she had not voted another ballot and understood that, by falsely signing the affidavit, she is guilty of a felony punishable by imprisonment for up to five years and/or a fine of up to ten thousand dollars.

RCW 29A.84.130 provides:

Any person who:

- (1) Knowingly provides false information on an application for voter registration under any provision of this title;
- (2) Knowingly makes or attests to a false declaration as to his or her qualifications as a voter;
- (3) Knowingly causes or permits himself or herself to be registered using the name of another person;
- (4) Knowingly causes himself or herself to be registered under two or more different names;

...

is guilty of a class C felony punishable under RCW 9A.20.021.

Trudy Garman/Wiseblood signed a registration form with the following conspicuous notice: "If you knowingly provide false information on this voter registration form or knowingly make a false declaration about your qualifications for voter registration you will have committed a class C felony that is punishable by imprisonment for up to five years, or by a fine of up to ten thousand dollars, or both imprisonment and fine."

I am forwarding this information to you for your action since the county auditor has the responsibility to report suspicions of voting fraud to the office of the prosecuting attorney. RCW 29A.84.010.

Registration and voting fraud are serious crimes that cannot be tolerated in a democracy. By illegally registering twice and casting second ballots, Ms. Garman/Wiseblood disenfranchised legal voters who had different political views. I trust that you and Prosecutor Maleng will initiate further investigation by law enforcement agencies and pursue prosecution to set the example for other persons who are tempted to commit voting fraud.

I would greatly appreciate your keeping me informed of follow-up actions.
