Dear Voter,

In processing your ballot for the **September 19, 2006 Primary and Special Elections**, it was determined that the signature on your returned ballot envelope does not match with the signature we have on file.

In accordance with state law (RCW 29A.60.165) for Elections staff to process your ballot, it is necessary that you complete one of the following actions:

- Sign a new voter registration form **in-person** at our office or at one of King County's community service centers. To assist you, please find attached a listing of all sites and operating hours where you may complete an in-person registration form. This information can also be found online at www.metrokc.gov/lars/csc/index.htm.

Additionally, we ask that you please bring this letter with you. Information on this letter will allow us to quickly match your completed voter registration form to your record and to finish processing your ballot.

- Sign the affidavit below and provide a photocopy of valid government or tribal identification that includes your current signature. Return both documents in the enclosed envelope.
- Sign the affidavit below in front of two witnesses who attest to your signature. Return document in the enclosed envelope.

If your ballot is to be processed for this election, it is imperative that King County Elections receive your mailed-in response or you appear in person no later than **September 28, 2006**.

AFFIDAVIT OF VOTER

I do solemnly swear or affirm, under penalty of perjury that:

- I am a legal resident of the state of Washington;
- I am entitled to vote in this election;
- I have not already voted in this election;
- It is illegal to vote if I am not a United States citizen;
- It is illegal to vote if I have been convicted of a felony and have not had my voting rights restored;
- It is illegal to cast a ballot or sign an absentee envelope on behalf of another voter, except as otherwise provided by law; and
- Attempting to vote when not entitled, attempting to vote more than once, or falsely signing this oath is a felony punishable by a maximum imprisonment of five years, a maximum fine of \$10,000 or both.
