

PRETRIAL DIVERSION AGREEMENT

I understand that I have been charged with the crime of Theft, the maximum penalty for which is one year in jail and a \$5,000 fine

I certify that I have not previously been convicted of a crime or been diverted as an adult in any jurisdiction.

I understand that I have the right to a trial by jury. I give up my right to a trial by jury. I understand that this is a final decision and that I cannot change my mind in the future.

I understand that I have the right to a trial within 90 days of my arraignment. I give up my right to a trial within 90 days of arraignment for an additional 180 days to 6/15/06

I understand and agree that if I successfully complete the conditions stated below, the charge will be dismissed. I understand and agree that if I do not successfully complete the conditions stated below, then the judge will read the police report and decide if I am guilty or not guilty based entirely upon the police report.

I have discussed this case with an attorney. I accept all of the terms of this agreement.

The conditions I agree to meet for the next three months are:

- 1. No criminal law violations.
2. Pay \$75 in fees to the Court and I waive any objection to the imposition of these fees
3. NCO - Orange Cab
4. Restit - 16.50
5. AIS -

I have discussed this agreement with the defendant and have reviewed the police report with the defendant. The defense stipulates to the admissibility of the police report into evidence should the Court find a failure to comply.

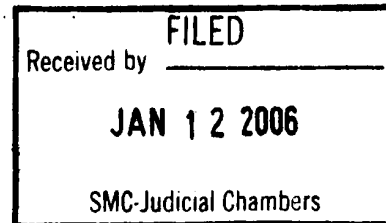
