As Public Disclosure Officer for the Snohomish County Auditor, I am responding to your public disclosure request dated December 27, 2004 at 10:27 PM and received via electronic mail at 7:51 pm, December 28, 2004.

For your information, effective November 1, 2004, the standard per page charge for documents provided pursuant to a public disclosure request will be \$0.25 per page. Requestors making a public disclosure request requiring postage, envelopes, CDs, Video or Audio Cassettes, or other supplies will be charged for those items at cost. Requestors may be charged an additional fee for large documents and for certain records covered by state statute. You are not required to purchase any document. You may make arrangements to view any identifiable documents by contacting me at the number below. At that time you may identify which document, if any you wish to purchase. For your convenience, the Snohomish County Auditor accepts cash, checks, and MasterCard or Visa.

The estimated cost of the information you have requested on CD will be \$20.50 provided the product is picked up in person. An additional \$2.00 will added to a request for the product to be mailed. The CD will be available AT 1:00 PM on Wednesday, December 29, 2004.

A "DECLARATION TO RELEASE LIST OF INDIVIDUALS" statement must be signed and returned to this office. The required form is attached for your use and information. Please bring this declaration with you at the time you pick up the requested product or return it by mail to my attention at 3000 Rockefeller Avenue, MS 204 Everett, WA 98201 or by fax to 425-259-2777.

This office may have possession of the declaration, as well as payment before the information will be released.

The list below details the content of the CD

- * date of birth - **DOB WILL NOT BE INCLUDED**
- * type of ballot submitted, (e.g. Polling Place, Absentee, Provisional) - **YES - WILL BE INCLUDED**
- HOWEVER, SNOHOMISH COUNTY DOES NOT DIFFERENTIATE BETWEEN ABSENTEE & PROVISIONAL BALLOTS**
- * an indication whether the ballot was accepted or rejected - **YES - WILL BE INCLUDED**
 - Y = POLLING PLACE ACCEPTED**
 - A= ABSENTEE ACCEPTED**
 - N= NOT VOTED**

- * an indication whether the ballot was accepted or rejected

The list should be presented in computer parsable format, ideally delivered by electronic mail or made available by download from your office website. A CD ROM would be acceptable if electronic delivery is not possible. Please confirm receipt and let me know when this data will be available.
