RCW 29A.40.040. TERMINATION OF ONGOING ABSENTEE/MAIL-IN VOTER STATUS. Status as an ongoing absentee/mail-in voter shall be terminated upon the occurrence of any of the following:

華盛頓州修訂法 29A.40.040. 終止持續性缺席或郵寄選民資格及身份. 若發生下列其中一項, 缺席或郵寄選民資格及身份將會被終止:

1. The written request of the voter; 選民用書面要求終止缺席或郵寄選民資格;
2. The death or disqualification of voter; 選民身亡或其選民資格被取消;
3. The cancellation of the voter's registration record; 選民登記的記錄被取消;
4. The return of an ongoing absentee ballot as undeliverable. 因郵局無法遞送, 缺席或郵寄選票被退回.
5. Upon placing a voter on inactive status under RCW 29A.08.620. 當選民在華盛頓州修訂法 29A.08.620 下被鑑定為一無選舉活動選民。
